## Kooyong Climate Change Alliance City of Boroondara Election 2024 Candidate Questionnaire

This questionnaire for candidates in the Boroondara election has been developed by the Kooyong Climate Change Alliance, a group of community organisations concerned about climate change including Lighter Footprints, ACF Boroondara and Move Beyond Coal Kooyong. The Alliance and its member organisations are non-partisan and will not be endorsing any candidates in the election.

The questionnaire has been developed to assist voters in understanding each candidate's commitment to the role Council can play in addressing climate change. The responses to the questionnaire will be used as the basis for a candidate scorecard for each Ward that will help voters make their decision. The scorecards and candidates' full responses to the questionnaire will be made available on our website and extensively advertised on social media. Printed scorecards will also be widely distributed to households during the voting period.

All the questions require a 'Yes', 'No' or 'Maybe' response, however candidates are also given the opportunity to make general comments. The comments will not affect the scoring, but will be available to voters via the website. Any unanswered questions will be given the lowest possible score.

These should be explicit goals of the Council for all Council owned facilities. Solar electricity generation, purchasing of green energy, battery storage, and energy efficient building and appliances, are proven and reliable technology, and should be implemented for council assets in a managed way. Council should conduct a Conversion Audit of all its assets to set out the method, timing, cost and implications of converting them to environmentally efficient buildings. The cost and waste of removing redundant technology must be balanced against the benefits of installing the new, and it must be accepted that the plan for each asset will vary according to its particularities, life cycle and available funding. More pocket parks should be created, and ghost development sites pursued for temporary greening. Tree planting along vacant fence lines bordering linear parks, which I call "Green Curtains", including along freeway noise walls, should be prioritized ahead of planting out all available open space which is also valued highly by society. Lobby State Government to green all freeway noise walls by planting vines and consider central medium strip canopy trees. ## 6. Other Comments

6.1 Do you have any other comments on meaningful climate action in Boroondara?

Demolition of existing buildings is extremely wasteful and has huge implications for our environment caused by the transportation and disposal of waste and the energy and resources required to manufacture new materials. Developers should be encouraged to reduce consumption by making use of existing building fabrics where possible. Reuse of building materials should also be encouraged by, for example, a Council sponsored "Renovators Op-Shop".

Similarly, our throw away society is deplorable. Council should consider leading attitudinal change by educating people on the cost of waste, by supporting and promoting centres that fix or recycle items, and by discouraging huge piles of hard waste collections. Can & bottle deposit centres should be encouraged in many more locations.
